#### V. PUBLIC PARTICIPATION

Rick Regan thanked the outgoing Board members for all their years of service to the Board of Education. He asked for clarification of a comment made by Dr. Voss at the October 19<sup>th</sup> meeting regarding the consulting firm for the superintendent search.

#### VI. BOARD AND ADMINISTRATIVE COMMUNICATIONS

- A. <u>Chairman's Report</u> Chairman Steve Burfeind spoke of the procedures for filling of the vacancy due to his resignation effective November 7<sup>th</sup>. He noted that six members will be voted onto the Board and will join incumbents Samantha Mannion and Ed Sbordone. This eight-member Board will meet during the week of November 27<sup>th</sup> and will appoint the ninth member to the BOE. The notice of the vacancy will appear in the *Town Tribune* and interested members must submit a letter of intent to Central Office by Friday, November 17<sup>th</sup> by noon. A special meeting of the newly elected BOE will be held during the week of November 27<sup>th</sup> to appoint a new member. The first meeting of the new Board will be on Thursday, December 7<sup>th</sup> and the Board will vote for officers.
- B. Superintendent's Report Dr. Alicia Roy spoke of the following:
  - Thanked the Consolidated School PTO for the Monster Run.
  - Thanked the MHHS School PTO for Masquerade/Fright Night.
  - The Annual Induction Ceremony for all of the high school honor societies was held on Monday, October 30<sup>th</sup>.
  - Parent/teacher conferences continue this week for Consolidated, MHHS and the Middle School.
  - Reminded everyone that clocks are set back one hour for the ending of Daylight Savings time this Sunday, November 5<sup>th</sup>.
  - There is no school on Tuesday, November 7<sup>th</sup> due to Election Day.
  - Thanked everyone for their cooperation on Monday, October 30<sup>th</sup> with traffic and road closures due to Sunday's storm.
  - Read a complimentary email from a referee for the Varsity Girls' Soccer team.
  - Noted that New Fairfield received two first place CABE awards for Excellence in Educational Communication. One was for the District Budget and the other was for the website. The district also received an honorable mention for the District calendar.
  - The upcoming District Vision plan and the updated Technology Plan will be presented to the BOE at a meeting in the near future.
  - Thanked outgoing board members Kevin Hearty, Jay Voss, Susan Starr and Steve Burfeind for all their work and dedication to the BOE.

# D. Committee Reports

- 1. <u>Curriculum</u> Kevin Hearty noted that this subcommittee met last week and discussed the elementary report cards and the philosophy of AP exams.
- 2. <u>Communications/Community Outreach</u> Ed Sbordone noted that this subcommittee met on November 1<sup>st</sup> and discussed the high school/middle school start time survey and noted that some of the surrounding towns are also contemplating this. This will be discussed further at the December 7<sup>th</sup> meeting. They also discussed the possibility of putting a traffic light at the entrance to the high school on Gillotti Road. ## A. Bipartisan State Budget Fiscal Year 2017-2018

Dr. Roy noted that a budget has been passed by the State of Connecticut and noted that New Fairfield will receive some funding that was originally thought to be cut by the state. Ed Sbordone noted that the final budget restored ECS money for New Fairfield and revenues were increased. This will be helpful for the budget for both this year and next year.

There was a brief discussion of the hiring of .6 Math teacher at the high school and whether or not it should be a full-time position.

# C. Strings/Music Program

Dr. Roy explained the budget process and how this position was affected by the budget and noted that since 2010 that only one .2 position was a lay off. Nearly thirty positions have been reduced since 2010. There was a discussion of the presentation to the Board about cutting the strings program and the possibility of more transparency.

## D. Approval of Grant Applications

This grant is in the amount of approximately \$4,000 and would be used for a before and after-school program for English learners.

This grant will be used for a .2 Strings Teacher for Meeting House Hill School.

This grant will be used for a guest speaker about drug and alcohol prevention and to supplement the Post-Grad party.
