 - D. <u>Legislative Update:</u> Supt. Glaes reported that while the Governor had postponed the \$127 reduction to the Per Pupil Foundation, MASA anticipates that there will be a reduction after the January 11 Joint Revenue Estimating Conference. Supt. Glaes also stated that Race to the Top legislation is expected to pass.

- A. Business and Finance Steve Goss
 - 1. <u>Monthly Budget Progress Report:</u> Asst. Supt. Goss reviewed the budget progress report for November 2009 showing total revenues of \$5,127,067; total expenditures of \$6,799,585; and deficiency of revenues over expenditures of -\$1,672,518. Mr. Goss stated that a budget amendment will be on the January agenda for approval.
- B. Instructional Report Weighted Grading Rob Kuhlman: Mr. Kuhlman explained the rationale supporting weighted grades using a 1.25 multiplier for VHS Advanced Placement, ATYP Advanced Placement courses, and KAMSC courses only, beginning with the current junior class. Upon investigation with several colleges, it will not be beneficial for 2010 graduating seniors to use weighted grading as most colleges have already determined the majority of scholarships.
- C. <u>Audience:</u> David Westman, Vicksburg parent, read a <u>Kalamazoo Gazette</u> article regarding the importance of arts in school. Mr. Westman asked that the Board take this into consideration when making budget cuts. Response: The Board knows and appreciates the VCS' history of having a strong arts program. The challenge is how to economically provide programs with what the State provides.
