The district issued a request for proposal for Contracted Services & Related Products RFP 24-010 – Extended Response and was awarded/approved on September 30, 2024. The proposal is for vendors/consultants/independent contractors who render services on a short/infrequent or frequent terms, on a fee or per diem basis. These services can provide administrative and/or technical expertise not otherwise available to or performed by district personnel. Services may consist of information, advisory, opinions, alternatives, conclusions, recommendations, demonstrations, or direct assistance, such as studies, analysis, and evaluations. Service categories can range from educational (subject specific), health & physical education, library media, educational technology, gifted & talented, advanced placement, bilingual, college and career readiness, fine arts, student evaluations, special education (PT/OT, speech pathology, and other therapies), athletics, student services, instructional learning, social emotional, mental health, and other miscellaneous contracted/consulting services as need districtwide.

With an extended response proposal, evaluations and awards are granted to additional vendors on a rolling basis throughout the solicitation period. This period remains open year-round until the final renewal option expires. Responses are evaluated as they are received, and vendors are notified of the district's decision accordingly. Newly approved vendors will be included in the list of awarded vendors submitted to the Board during each annual renewal. This means that while vendors may be added throughout the year under the extended response process, their names and award details will be formally reported as part of the renewal documentation submitted for Board review and approval each year.

The following vendors were awarded on RFP 24-010 for Contracted Services & Related Products – Extended Response. The district has opted to extend the award of this RFP using the first extension option.
