The Recent History of State Assessment and Changes in the Tomahawk School District

During the **2012-2013** school year:

- The **WKCE** was given to grades 3-8 and 10 in the fall.
- PALs testing was given to students 4K-K two times per year.
- WAA testing was given to special educations students with significant cognitive disabilities in grades 3-8 and 10, instead of the WKCE.
- ACCESS testing was administered to our ELL students in the winter.

These were all required state assessments.

District assessment data collected included:

- **AIMS web testing** in two math areas and two reading areas for all students in grades 6-8 three times per year,
- F+P testing in grades K-5 three times per year and
- math assessment data on every unit in math grades K-5.
- **MAP** assessment was purchased and administered in language arts, reading, and math to select grades in the elementary during second semester.

I could be missing some, I wasn't the C+A director then.

During the **2013-2014** school year:

- The WKCE was given to grades 3-8 and 10 in the fall.
- **PALs** testing was given to students 4K-1 twice per year, one grade voluntarily gave the assessment three times.
- WAA testing was given to special educations students with significant cognitive disabilities in grades 3-8 and 10, instead of the WKCE.
- ACCESS testing was administered in the winter to our ELL students.

These were all required state assessments.

District assessment data collected included:

- AIMSweb testing only for students receiving interventions in grades 6-8,
 - second semester in the elementary by teachers who volunteered to give **aimsweb** testing and progress monitoring a try.
- **F+P** testing in grades 3-5 was replaced with **aimsweb** testing by second semester, and we ended the practice of collecting math assessment data on every unit in math grades K-5.
- **MAP** assessments were administered to all students grades 2-8 three times in Language Arts, Reading, and Math.

Current school year

2014-2015: The new educator effectiveness laws went into effect, as did changes in state testing. I will reflect these changes in a spreadsheet form. We stopped requiring **F+P** testing of every student at every grade level in the elementary. Below you will find the law and important DPI rules on this.

State statute 115.415 requires that teachers be evaluated using the DPI established or adopted teacher evaluation system (educator effectiveness, two options: Teachscape or My Learning Plan) and the law that require that 50% of the evaluation be based on student performance.

During the 5 step process, the DPI outlines the need to assess students 4 times over the course of the year. This is further complicated by the requirement that principals need school wide data for their building **SLOs**.

Our staff uses **MAP**, **AIMSweb**, **PALS**, or other common assessments to meet the requirements for **SLOs**. Assessments must be given a minimum of three times a year to meet the requirements of this rule, and the DPI suggests 4 to 5 times a year is better.

<u>The Future</u>

2015-2016: Rumors are flying around what will happen for the 2015-2016 school year. Odds are good some things will change. For certain, we will be giving **ACCESS** testing 2.0 next year, which is an electronic version of the **ACCESS** test for our **ELL** students. Beyond that, we are being told everything will remain the same as the 2014-2015 school year.

Definitions:

- ACCESS: Testing for students who have English as their second language.
- AIMSweb: A compilation of 4 assessments that assess areas in reading and math, that take approximately 5min to administer and will be used to track students as they receive interventions. This assessment meets a requirement of the new special education law to qualify students with learning disabilities for special education services.
- Smarter Balanced assessment: The state has renamed this the Badger Exam.
- ELL : English Language Learners (students who have English as their second language)
- F&P: Fountas and Pinnell assessment, this is an excellent reading assessment that can take an hour or more per child to administer.
- MAP: Measures of Academic Progress assessment. A very common exam given to students across the nation to measure achievement on common core standards. It is so common, that the department of instruction has started a pilot program that allows schools to import their MAP data to the state assessment dashboard site.
- PALS: Phonological Awareness Literacy Screening. A reading assessment given to students 4K-2.
- SLO: Student Learning Objective for teachers, School Learning Objective for principals.
- WAA: Wisconsin Alternative Assessment. Assessment given to special needs students that are not capable of taking regular state assessments.
- WKCE: Wisconsin Knowledge and Concepts Exam. State test that we still are required to administer to students in grades 4, 8, and 10 on Science and Social Studies curriculum from 1998.
