# 1. Provide a DETAILED RATIONALE explaining how the waiver will enhance student learning opportunities, promote innovation, or increase equitable access to effective teachers. Include information about the problem or obstacle, if any, the waiver will help the district overcome.

The Dierks School District is requesting a waiver from A.C.A. 6-10-106, which establishes the first allowable day of class as the Monday of the week that contains August 19. For the FY25 school year that date is Monday, August 19, 2024.

The specific waiver requested is to allow the school district to set the first day of class to be "no earlier than Tuesday, August 13."

The advantages of this waiver include but are not limited to:

- A. The number of days for instruction the first semester would more closely align to the number of days for instruction in the second semester. We are a four-day week school district. The number of days required for a four-day school is 143. The waiver would give us 72 days in the first semester and 71 days in the second semester.
- B. There would be an increase in the number of days of instruction prior to spring testing rather than days of instruction after spring testing.
- C. The ending of the school term would align to community needs for the last day of school before Memorial Day.
- D. For inclement weather situations, it would allow a few days of makeup following Memorial Day prior to June should inclement prohibits instruction during school term.
- E. Student engagement is much higher at the beginning of the school year versus the ending of the school year. Engaged students equate to more learning at any level.

#### 2. Provide a detailed explanation of how the services being waived will be provided for students.

The Dierks School District will create a calendar with an earlier start date which will provide them with more flexibility throughout the school year. The school year will remain the same length. This would allow the district to continue with a school calendar structured as closely as possible to the current one and avoid dramatic changes to the calendar which would result without the waiver.

# 3. Provide a detailed explanation of how the district will monitor and evaluate the effectiveness of the waiver.

Dierks School District will monitor student assessment results and student attendance data related to the earlier state date to determine the effectiveness of the early start date.
