Notice of Regular Meeting Board of Trustees Thursday, October 16, 2025

A Regular Meeting of the Board of Trustees will be held on Thursday, October 16, 2025, beginning at 6:30 PM, in the Cafeteria, 200 Co Rd 421, Stephenville, TX 76401.

1. Call to Order and Establish Quorum

The meeting was called to order and a quorum established at 6:30 PM by Vice President, Brett Thetford. The board members in attendance were Brett Thetford, Cindy Shipman, Lance Brooks, Neil Culpepper, and Betty Peterson. The administrative staff in attendance were Superintendent, Wes Corzine and Principal, Molly Purl. Business Manager, Yvette Thomason was also in attendance.

2. Invocation

The invocation as led by Mr. Corzine.

3. Pledges of Allegiance - United States and Texas

4. Student Highlight - Cross Country

HISD Coaches, Marianne Wienecke and Kia McCarty, introduced girls and boys cross-country junior high and high school athletes. The students represented Huckabay at the district cross country meet held in Gorman where they won the district championship for all grade brackets. These students will compete at the regional level at UT Arlington on October 20th.

5. Public Comment

There were no public comments.

6. Overview of Huckabay ISD 2024-2025 FIRST Rating

Mr. Corzine presented the 2024-2025 FIRST Ratings based on HISD's 2023-2024 audited financial data. Huckabay ISD received a passing status with a score of 100. This is the fourth consecutive year Huckabay has received this score.

7. Public Hearing on FIRST Rating

The public hearing regarding HISD's FIRST rating began at 6:40 PM. There were no public comments and the hearing closed at 6:42 PM.

9. Principal Report

A. Attendance/Enrollment

Principal, Molly Purl, shared that the total student enrollment at the time of the meeting was 346; this is an increase of six students since the meeting held in September.

The overall student attendance was 97.03%. Mrs. Purl told the board that an attendance challenge will begin the third six-weeks of school where winning grades receiving an ice cream or pizza party.

B. Upcoming Events

Mrs. Purl shared a calendar of events for October and November, and also said that parent/teacher conferences to go over MAPS testing results would be held on Friday, October 24th.

Coaches Kia McCarty and Jacob Fain presented information to the board on the new UIL initiative, *The Texas Way*, that promotes positive sportsmanship and respect between students and parents. *The Texas Way* sportsmanship curriculum is based on three pillars. The first pillar is Respect for Others, the second pillar is Control of Self, and the third pillar is Spirit of Competition. HISD student athletes and coaches are currently using and discussing *The Texas Way* curriculum.

Coach McCarty shared that HISD basketball will host a first ever tournament titled >104.9 Invitational Tournament the first Thursday through Saturday in December. The tournament will include girl and boy basketball teams.

10. Superintendent Report

A. Fall Festival Report

Mr. Corzine shared with the board that the fall festival had raised \$81,276. He thanked the board members that came and helped with the festival.

B. November Board Meeting - November 13

The next regular board meeting will be moved from November 20th to November 13th. The auditors of Snow Garrett and Williams will present the 2024-2025 HISD audit report.

11. Annual Review of HISD Board Policy CDA (Local) - Investments

Mr. Corzine discussed the current investments accounts for HISD. He said that Huckabay participates in TexPool and First Financial Bank Money Market accounts for a total of four accounts. He also shared the interest income and rates for the past year. There were no changes to HISD Board Policy CDA (Local).

12. Discussion Item(s)

A. Classroom Renovations

Mr. Corzine shared an update with the board regarding classroom renovations in the old ag building. The attorney for HISD suggested receiving a design build from a company that is familiar with school building and ADA compliance laws. There is currently \$522,371 committed fund balance assigned for construction in the general fund. A resolution can be made to unassign or recommit these funds towards the renovations.

The board discussed various next steps which include reaching out to local construction companies to see if there is any interest in bidding the project.
