RESOLUTION RELATING TO PROPOSED PROPERTY TAX ABATEMENT FOR ICE ARENA AND FIELD HOUSE ACQUISITION; CALLING A PUBLIC HEARING THEREON

BE IT RESOLVED by the School Board (the Board) of Independent School District No. 831 (Forest Lake Area Schools), Minnesota (the District), as follows:

1. Proposed Abatement.

The District, pursuant to Minnesota Statutes, Sections 469.1812 to 469.1815, as amended, is authorized to grant an abatement of the property taxes imposed by the District on all properties within the District boundaries (collectively, the Property), if certain conditions are met, through the adoption of a resolution specifying the terms of the abatement. It has been proposed that the District acquire the ice arena and field house known as the Lichtscheidl Arena and Field House from the Forest Lake Area Athletic Association in order to provide recreational services to District residents (the Project). In order to finance the Project, it has been proposed that the Board grant a property tax abatement on the Property in an amount not to exceed \$3,400,000 over fifteen (15) years (the Proposed Property Tax Abatement), and that this Board hold a public hearing on the Proposed Property Tax Abatement as required by Minnesota Statutes, Section 469.1813, subdivision 5.

2. Public Hearing.

A public hearing is hereby scheduled to be held on the Proposed Property Tax Abatement at 6:00 p.m. on Thursday, May 30, 2013, at the District offices located at 6100 N. 210th St., Forest Lake, Minnesota. The School District Clerk is hereby authorized and directed to cause notice of such public hearing in substantially the form of Exhibit A hereto to be published in the official newspaper of the District more than ten (10) days but less than thirty (30) days prior to the date of the hearing.

NOTICE IS HEREBY GIVEN that the School Board of Independent School District No. 831 (Forest Lake Area Schools), Minnesota (the District) will hold a public hearing on 6:00 p.m. on Thursday, May 30, 2013 at the District offices located at 6100 N. 210th St., Forest Lake, Minnesota to consider granting an abatement of the property taxes imposed by the District (the Proposed Property Tax Abatement) on all properties within the District boundaries.

The purpose of granting the Proposed Property Tax Abatement is to provide funds to acquire the ice arena and field house known as the Lichtscheidl Arena and Field House from the Forest Lake Area Athletic Association in order to provide recreational services to District residents. The total estimated amount of the Property Tax Abatement by the District is \$3,400,000 over fifteen (15) years.
