WRA Architects, Inc. is pleased to present the following proposal for Architectural / Roofing Services to Chico Independent School District for the following project:

## 2015 Chico Middle School Roofing Renovations

<u>A/E Fee</u>: The Architectural / Roofing Service fee for this project is based on a flat fee based on anticipated re-roofing construction costs. WRA Architects offers a minimum basic services fee of:

**WRA Architects:** 

Proposed Fee of \$ 2,500

Scope includes specifications for bidding and two trips to the site.

**Apex Roofing Consulting:** 

Proposed Fee of \$ 9,838

Scope includes roofing specifications and drawings - see attached proposal.

The assistance anticipated to be needed to effectively define the requirements of the project is included in the above basic services fee. The scope of the work is understood to include, but not limited to, the following:

• Chico Middle School: Provide design requirements for installation of the appropriate Duralast roofing system for each roofing condition on the campus. Provide design requirements for removal of the existing loose gravel on the existing built-up roof, design requirements for installation of new insulation and Duralast roofing system, design new flashings at rise walls and roof penetrations. The system shall be complete with necessary flashings and sheet metal trim work for a complete installation.

It is the recommendation of WRA Architects, Inc., that the work be issued as a Competitive Sealed Proposals as the method of construction services procurement.

<u>General Schedule</u> for the stated A/E basic services for the roofing project is defined in the Roofing Consultant's proposal and will become effective on the date of approval by the school district.

The Architectural/Engineering fees are to include construction drawings and specifications documentation, bidding/negotiation assistance, and construction administration as noted in the Roofing Consultant's Proposal. Structural Engineering Services are not included in the above noted fee. MPE engineering services are not provided as part of this proposal as it is assumed that the existing mechanical, plumbing and electrical equipment on the roof of the building will be re-remain in place or be reinstalled by the roofing subcontractor. These project requirements will be included in the Project Manual.

The following project related services are not under the Architects' scope of responsibility and if required shall be contracted directly with the school district: boundary and topographic survey, site platting, environmental testing including asbestos survey, geo-technical investigation and foundation

**Reimbursables:** The school district will pay the architect for standard reimbursable expenses for printing of the bid sets of drawings and specifications. The architect and roofing consultant shall be reimbursed travel for each site visit. For reimbursable expenses, the compensation will be computed as a multiple of **1.0** times the expenses actually incurred by the Architect.

Additional services requested by the school district resulting in added scope to the project are to be reimbursed on a pre-agreed amount approved by both parties.

<u>Statements</u>: Statements will be itemized and identified as Basic Services, Additional Services or Reimbursable Expense. Unless otherwise stated, statements will be submitted monthly for charges incurred during the month, and payments will be due within thirty (30) days following receipt of the statement.

<u>Initial Fee Billings</u>: Architect's Basic Services are based on percentage of work complete in design and construction. Architect is to be compensated for design work requested by the Owner but not included in the construction contract as a result of alternate bids not accepted or reductions in the budget.

Bidding/Negotiation Phase	10%
Construction Phase	30%

<u>Schedule of hourly fees</u>: Except as stipulated otherwise in the Owner-Architect agreement, payment for architectural additional services will be performed at the hourly rates, which follow. These rates and multiples shall be annually adjusted in accordance with normal salary review practices of the Architect:
