TRAVELSCHOOLSPONSORED TRIPS IN
GENERAL

Students who participate in school-sponsored trips outside Ector County or the city limits of Odessa shall be required to useride in transportation provided by the Districtschool to and from the event except as otherwise permitted in administrative regulations.

## IN-STATE OVER-NIGHT TRIPS

An exception may be made if the student's parent or guardian requests in Any in-state overnight trips taken by writing that the student organizations and be allowed to ride with the parent or other designated adult who is not a student groups shall require approval from the Superintendent.

If it is impractical for students to meet at school and then be transported by school-provided transportation, coaches or sponsors may use discretion in allowing students to be transported by a parent/guardian or transport themselves or a sibling or be transported by a sibling to a school-sponsored event within Ector County or the city limits of Odessa.

OVERNIGHT TRIPS— EARLY CHILDHOOD THROUGH SIXTH GRADE Students may be permitted to take school-sponsored overnight trips for the following purposes:

- 1. Instructional purposes (field trips and excursions) for the grade level. Approval for the trip shall be from the Superintendent or designee.
- 2. District-sanctioned competition. Approval for the trip shall be from the Superintendent or designee.

## OVERNIGHT TRIPS — GRADES 7–12

Students may be permitted to take school-sponsored overnight trips for the following purposes:

- 1. Instructional purposes (field trips and excursions). Approval for the trip shall be from the principals.
- Activities of school-sponsored or -sanctioned clubs or organizations. Approval for the trip shall be from the Superintendent or designee.
- 3. UIL competition. Approval for the trip shall be from the principal.
- 4. District-sanctioned competition. Approval for the trip shall be from the Superintendent or designee.

## OUT-OF-STATE TRIPS — GRADES 9-12

AnyStudents may be permitted to take out-of-state trips taken by studentschool-sponsored trips for the following purposes:

1. Activities of school-sponsored or -sanctioned clubs or organizations or other student groups. Approval for the trip shall require approval be from the Board.
