Ready to Serve Pizza CSP 100518-PIZ

June 22, 2010

SUMMARY:

- This item requests approval of CSP 100518-PIZ, for Ready to Serve Pizza, for one term of two years with the option to extend, upon governing body approval, for two additional terms of one year each.
- Pizza Hut was ranked first of five proposals submitted including Cici's, Domino's, JNJ's, and Olive Branch.

BOARD GOAL:

VI. Growth and Change and fiscal responsibility... demonstrate effective and efficient management of district resources.

PREVIOUS BOARD ACTION:

- The last proposal was approved on May 23, 2006 for a term of two years with two extensions of one year each.
- The last extension was approved on June 9, 2009.

BACKGROUND INFORMATION:

- The proposal is used to purchase Ready to Serve Pizza for the secondary campuses and games at Collins stadium. A committee convened to review the proposals. The committee consisted of Robin Wantland, Kathy Arrington, and Alyce Hamman.
- A blind tasting was held at Guyer High School monitored by Robin Wantland. Thirty-three students were chosen to participate in the blind tasting. They rated each sample on a scale of 1-10 (10 being the best) for taste, appearance, aroma, temperature, and overall quality. The blind tasting counted as 50% of the total ranking score.
- After the results of the tasting were compiled by Robin Wantland, the committee convened to prepare the final Ranking.
- Pizza Hut received the highest score from the tasting for both types of pizza, cheese and pepperoni.
- The individual results of the blind summary are located in Robin Wantland's office.

SIGNIFICANT ISSUES:

- The current proposal will expire June 30, 2010.
- Pizza Hut ranked 1st overall with a price of \$5.95 for Cheese and Pepperoni.
- Cici's ranked 2nd with a price of \$6.50 for Cheese and Pepperoni.
- Olive Branch ranked 3rd with a price of \$6.00 for Cheese and \$6.15 for Pepperoni.
- JnJ's ranked 4th with a price of \$6.99 for Cheese and Pepperoni.
- Domino's ranked 5th with a price of \$6.50 for Cheese and Pepperoni.

FISCAL IMPLICATIONS:

Costs will be borne by the Child Nutrition Enterprise Budget.

BENEFIT OF ACTION:

Passage will allow students at the secondary campuses to purchase Ready to Serve Pizza for lunch. It will also allow the district to sell pizza at Collins Stadium during the athletic season.

PUBLIC COMMENT RECEIVED:

A blind tasting was held at Guyer High School monitored by Robin Wantland. Thirty-three students were chosen to participate in the blind tasting. They rated each sample on a scale of 1-10 (10 being the best) for taste, appearance, aroma, temperature, and overall quality. The blind tasting counted as 50% of the total ranking score.

OTHER COMMENTS:

- As requested, Pizza Hut submitted a healthy option pizza for both Pepperoni and Cheese at a price of \$6.20 each. During the summer, Robin will meet with the contact from Pizza Hut to decide on the best healthy options to serve. At least one type will be offered each day at the middle and high schools.
- Pizza Hut submitted two types of healthy option pizzas, JnJ's offered two types and Olive Branch offered one type. Cici's and Domino's did not offer a healthy option pizza.

SUPERINTENDENT'S RECOMMENDATION:

It is recommended that the Board accept the recommendation of the committee to award the Ready to Serve Pizza contract to Pizza Hut, in the amount of \$5.95 per pizza for Cheese and Pepperoni and \$6.20 for each healthy option pizza, for a period of two years with the option to extend the contract, upon governing body approval, for two additional terms of one year each.
