Summary:	In accordance with the Texas Education Code (TEC), Chapter 45, Subchapter G, each school district must select a depository to receive school funds during the 2021-202 biennium. Bellville ISD is eligible to extend its current depository contract in accordance with the TEC, §45.205(b).	

As a school district, we are entrusted to maximize safety and yield of funds. While these uncertain economic times lend to safety as a primary goal, it is also our duty as stewards of public funds to see that we are earning a reasonable market rate. Industry State Bank is committed to working with Bellville ISD to achieve an above market rate. The current rate extended to all funds under the bid contract is 30 basis points above the 90 day Treasury Bill or a floor of 1.26%.
