Rudolph and Mary Ann Rudolph to Henry Frank Hawlowitz by deed dated August 6, 1914, recorded in volume 53, page 268 of the Deed Records of Bee County, Texas, such interest is included in the Property.

WHEREAS, the Board of Trustees has determined that the Property should be advertised for sale pursuant to §272.001(a) of the Texas Local Government Code;

WHEREAS, the Board of Trustees has determined that the Property should be sold, subject to approval by the Board of Trustees of an offer; NOW THEREFORE BE IT

RESOLVED that the findings and recitals in the preamble of this Resolution are hereby found to be true and correct and are hereby approved and adopted.

RESOLVED, that the Board of Trustees authorizes the Superintendent of Schools, or her designee, to publish notice to the general public of the proposed sale to prospective parties in accordance with §272.001(a) of the Texas Local Government Code, to receive and open sealed proposals, and to present said proposals to the Board of Trustees;

RESOLVED, that the Board of Trustees is not obligated to accept any proposal or offer or to complete a sale;

RESOLVED, that it is hereby found, determined and declared that sufficient written notice of the date, time, place and subject of the meeting of the Board of Trustees of the Beeville Independent School District at which this Resolution was adopted was posted at a place convenient and readily accessible at all times to the general public for the time required by law preceding this meeting, as required by chapter 551, Texas Government Code, and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The Board of Trustees further ratifies, approves and confirms such written notice and posting thereof.
