Adaptability: students and staff demonstrating resilience and flexibility while transitioning through the ACT and IAR scheduling and embracing new curriculum changes. Contribute: students engaged in community service across all grade levels. Initiatives like the district-wide Service Day that included activities like clean ups and care package assembly. Collaborate: this includes coordinating events like the Prom Crash reenactment, working with local first responders and staff. Think Critically: Students participated in activities like Shark Tank and the Wax Museum along with courses like Creative Writing and CTE Internship. Problem Solve: Our operational leaders tackled outdated systems with new technology solutions, while teachers used data to plan interventions and enrichments.

The Special Olympics was highlighted as a milestone for HBR as it launched its first ever Special Olympics team this year. A continuation of our District's commitment to inclusion and student opportunity. A huge shout out to Coach Zill for her leadership and dedication in bringing the vision to life.

Operations had a big year of improvements. This included launching a new maintenance request system and tracking its progress weekly with team meetings, facility improvements like LED lighting at all 3 buildings and the soccer field, HVAC upgrades, fence replacements, phone and server upgrades just to name a few.
