V.2. Consideration of Request for Act 1240 Waiver by Jacksonville North Pulaski School District

Item V.2. was presented by Mr. Stephen Reynolds, DESE Attorney. Also present were Mr. Michael Vincent, Instructional Technology Coordinator and Ms. Lorri Stinnett, School Improvement Specialist. The Jacksonville North Pulaski School District is seeking three Act 1240 Waivers to continue its digital learning program: 1) attendance, 2) six-hour instructional day, and 3) clock hours and recess. These waivers are only being requested for three years.

A motion to approve the three Act 1240 waivers for three years was made by Ms. Kathy Rollins, seconded by Mr. Steve Sutton. The motion unanimously passed.

V.3. Recommendation for Accredited - Probation Status for the Cutter Morning Star School District

Item V.3. was presented by Mr. Andres Rhodes, Chief Legal Counsel, Ms. Shastady Wagner DESE Attorney Specialist, and Mr. Matthew Sutherlin, Coordinator, Standards and Systems of Support/Charter. Also present was Dr. Nancy Anderson, Superintendent and Ms. Laura Baber, Director of Administrative Support.

The Division of Elementary and Secondary Education recommends that the Cutter Morning Star School District be placed on Accredited - Probation Status for violation of Standards 2-B.2 which states that "[e]ach public school district shall maintain accurate student attendance records in a format prescribed by the Division." (D/P) and Standard 3-A.3 which states that "[e]ach public school district shall submit accurate and timely reports deemed necessary to assure compliance with federal and state law and the rules of the Division, as requested." (D/C) The Cutter Morning Star School District timely filed an appeal of the Division's recommendation.

Mr. Rhodes confirmed with Mr. Jay Bequette, BBK Law that Cutter Morning Star had legal representation present. Upon confirmation of legal representation, Mr. Rhodes provided Mr. Bequette with an opportunity to speak in response to Dr. Anderson's admissions; Mr. Bequette declined.

A motion to affirm the recommendation of the Division of Elementary and Secondary Education to place Cutter Morning Star on Accredited – Probation Status for violation of Standards 2-B.2 (D/P) and 3-A.3 (D/C) was made by Mr. Jeff Wood, seconded by Mr. Steve Sutton. The motion unanimously passed.

Description: Educational Testing Service (ETS) has updated four 7-12 science Praxis[®] tests and three K-12 school professional tests currently used by DESE for various educator licenses. DESE recommends adopting updated Praxis[®] assessments for Life Science/Biology (7-12), Chemistry (7-12), Earth Science (7-12), Physics (7-12), Guidance and Counseling (K-12), Library Media Specialist (K-12), and School Psychology Specialist (K-12).

Praxis[®] Biology (5236) - passing score of 142 Praxis[®] Chemistry (5246) - passing score of 133 Praxis[®] Earth and Space Sciences (5572) - passing score of 141 Praxis[®] Physics (5266) - passing score of 133 Praxis[®] School Counselor (5422) - passing score of 146 Praxis[®] School Librarian (5312) (fm. Library Media Specialist) - passing score of 141 Praxis[®] School Psychologist (5403) - passing score of 142
