Lot 17, Block 2, Brenhaug and Danielson Addition to the City of Roseau, Roseau County, Minnesota

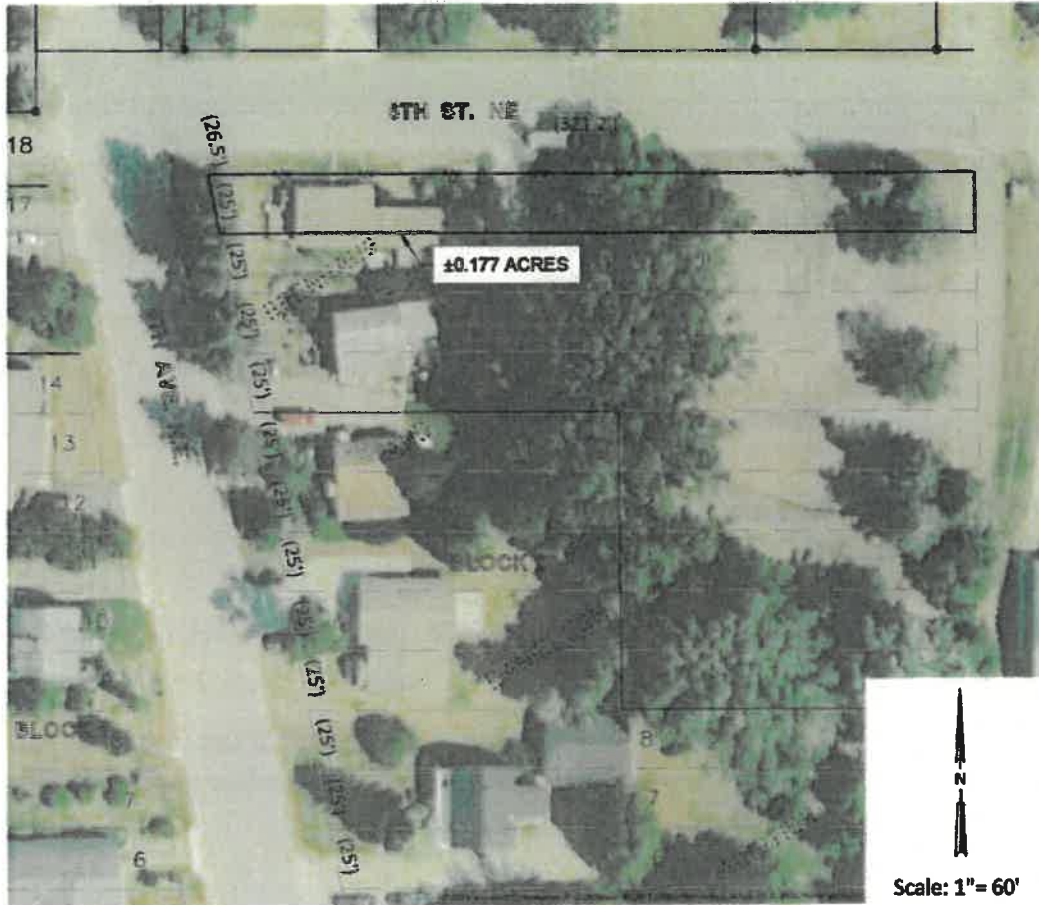

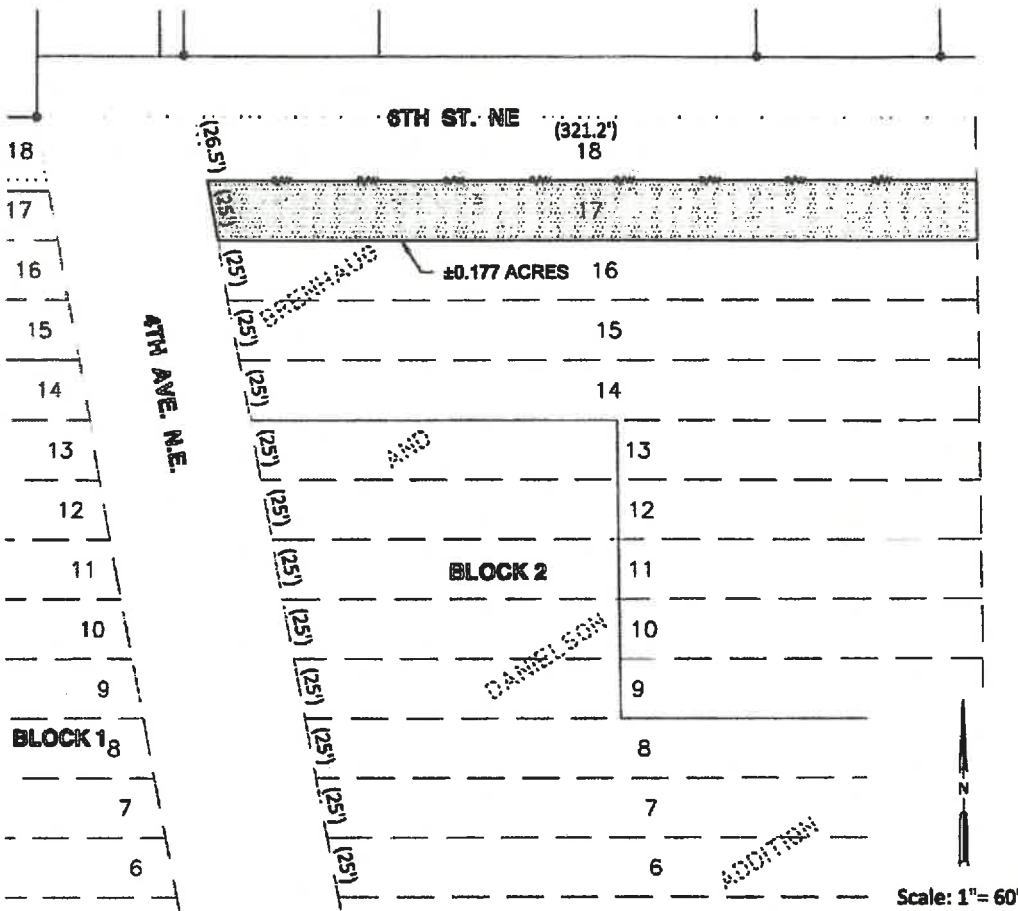
