Vicksburg Community Schools received 29 proposals for 9 bid packages that was solicited as Series 3 Release 2 - VCS High School, Middle School & Sunset Lake Elementary Flooring & Restroom Renovations, part of the VCS 2020 Bond Projects on December 19, 2024. (*See attached Bid Tab*).

B.P. 2.4- Restroom Selective Demolition-1 proposal received.

B.P. 2.8- ACM & Non-ACM Classroom & Corridor Flooring Demolition- 4 proposals received.

- B.P. 9.0- Terrazzo Refinishing- 1 proposal received.
- B.P. 9.2- Metal Studs & ACT Ceilings- 2 proposals received.
- B.P. 9.3- Restroom Tiling- 3 proposals received.
- B.P. 9.6- Classroom & Corridor Flooring 3 proposals received.
- B.P. 9.9- Painting- 6 proposals received.
- B.P. 22.1- Plumbing & Mechanical Improvements- 5 proposals received.
- B.P. 26.1- Electrical Improvements- 4 proposals received.

Below is our final review, evaluation, and award recommendation.

B.P. 2.4 – Restroom Selective Demolition

The Bid Package Work Scope consists of: Demolition of existing Partitions, toilet room accessories, masonry chase walls, floor slab saw-cutting and removals and ceramic tile floor removals at Sunset Lake Elementary , Tobey, and Indian Lake Elementary buildings.

Abatement Demolition Services

Base bid:\$165,645.00Total Current Proposed Contract Amount\$165,645.00

We are recommending that this bid package be awarded to Abatement Demolition Services.

B.P. 2.8 – ACM & Non-ACM classroom & Corridor Flooring Demolition

The Bid Package Work Scope consists of: Removal of all Non-ACM and ACM floor coverings in the corridors and classrooms scheduled for new flooring at Sunset Lake Elementary, Vicksburg Middle School, and Vicksburg High School buildings.

<u>Special Note</u>: Bidders that provided proposals for Bid Package 2.8 – ACM & Non-ACM classroom & corridor flooring demolition had the option to provide pricing for the scope defined at Sunset Lake Elementary and the VCS Middle School as one project, the VCS High School as a project or provide a

combined bid for both. Bid results were examined and it was determined that there was a cost savings to the school district to award both the Sunset Lake and VCS Middle School project scope and VCS High School project scope to the selected contractor below.

The Bid Package Work Scope consists of: foundations, structural steel installations, metal stud framing, wall sheathing of new chase walls, installation of new ceilings, installation of bathroom accessories, and supply and installation of new bathroom toilet partitions at Sunset Lake Elementary, Vicksburg Middle School, and Vicksburg High School buildings.

B.P. 9.3 – Restroom Tiling

The Bid Package Work Scope consists of: Installation of all indicated areas of floor and wall porcelain tile in restrooms at Sunset Lake Elementary, Vicksburg Middle School, and Vicksburg High School buildings.

We are recommending that this bid package be awarded to Ritsema & Associates.

B.P. 9.6 - Classroom & Corridor Flooring

The Bid Package Work Scope consists of: Installation of new resilient flooring, carpet tile, and entrance walk-off carpet tile in classrooms, corridors, and common spaces at Sunset Lake Elementary, VCS Middle School, and VCS High School buildings.

<u>Special Note</u>: Bidders that provided proposals for Bid Package 9.6 – Classroom & corridor flooring demolition had the option to provide pricing for the scope defined at Sunset Lake Elementary and the VCS Middle School as one project, the VCS High School as a project or provide a combined bid for both. Bid results were examined and it was determined that there was a cost savings to the school

district to award both the Sunset Lake and VCS Middle School project scope and VCS High School project scope to the selected contractor below.

Ritsema & Associates – Flooring & Tiling DivisionBase bid: \$1,122,895.00Total Current Proposed Contract Amount\$1,122,895.00

We are recommending that this bid package be awarded to Ritsema & Associates.

B.P. 9.9 – Painting

The Bid Package Work Scope consists of: Painting of classrooms, corridors, select overhead ceilings and common spaces at Sunset Lake Elementary, Vicksburg Middle School, and Vicksburg High School buildings. This Bid Package also had an alternate requested which obtained pricing to paint the interior walls of the VCS Middle School Gymnasium.

<u>Special Note</u>: Bidders that provided proposals for Bid Package 9.9-Painting had the option to provide pricing for the scope defined at Sunset Lake Elementary and the VCS Middle School as one project, the VCS High School as a project or provide a combined bid for both. Bid results were examined and it was determined that there was a cost savings to the school district to award the Sunset Lake and VCS Middle School project scope and VCS High School project scope to the two separate contractors noted below.
