# Minutes of Special Meeting The Board of Trustees Uvalde Consolidated Independent School District

1. Call to Order

The motion was made by JJ Suarez and seconded by Javier Flores to move authorize legal counsel to prepare a pleading including a proposed resolution to be filed in the US District Court for the Western District of Texas to allow Uvalde CISD to return its election system to align more closely with the 1982 Consent Decree. K. Trustee Quinones shared concerns of grants ending in September with a remaining balance. Pam Bendele responded that some of the grants have a provision to carry over a certain percentage. If there is a balance some of it may be moved to the federal fund without violating guidelines.

L.- Trustee Robert Quinones asked why such a large dip in April. This is due to the Easter holiday and a large amount of threats. Mr. Quinones stated we need a District PEIMS position. We have a District PEIMS Coordinator.

Trustee Jesse Rizo recognized campuses over 90% attendance: Batesville and UDLA

M.-Trustee JJ Suarez is concerned about dress code issues. Mr. Suarez would like for the Police Chief to come in with a plan to help minimize fights and present to the board at the June regular board meeting.

Trustee Laura Perez suggested maybe start an internship program. Trustee Jesse Rizo asked about student accident insurance provided by the school district.
