MN Statute 123B.52 states that "contracts for the purchase of perishable food items, except milk for school lunches and vocational training programs, in any amount may be made by direct negotiation by obtaining two or more written quotations for the purchase or sale, when possible, without advertising for bids or otherwise complying with the requirements of this section or section 471.345, subdivision 3. All quotations obtained shall be kept on file for a period of at least one year after receipt." Per MN statute 123B.52, the district must follow the sealed bid process as defined in MN statute 471.345 for milk distribution.

Milk bids were received in the district offices for the milk supply in regards 2023-2024 and 2024-2025 years. Only one bid was received. The bid was from Performance Foodservice. A recap of the bid is listed below:
