Quote for Braswell and Bell Acoustic Pianos

SUMMARY:

This item requests approval of the BuyBoard quote from the Clavier Group, Inc./Steinway Pianos for the acoustical Pianos for Braswell and Bell.

BACKGROUND INFORMATION:

In standardizing the purchases of acoustic pianos, the district first selected the Yamaha piano as the preferred brand, and then changed to the Baldwin piano when the desired Yamaha models were no longer available. As a result of input from teachers who indicated that the Baldwin pianos do not hold tune as well as expected, the district explored a more reliable brand.

With teacher feedback and positive comments from several other school districts who are currently using this brand, the district recommendation is to standardize piano purchases with the Boston piano which is a sub-division of the Steinway Company. Steinway pianos have long been recognized as a leading brand in piano manufacturing and distribution of high quality pianos. The Boston piano is made with the Steinway parts and to Steinway specifications and should provide the district with quality instruments that area affordable, functional and durable.

SIGNIFICANT ISSUES:

Pricing includes a limited 10 year warranty on parts and labor, bench & delivery. One tuning prior to delivery and one tuning on-site. All pianos have factory installed locks. Covers and heavy-duty dollies are also included.

FISCAL IMPLICATIONS:

Cost will be borne by 2013 FF&E Bond funds.
