ACTION

BACKGROUND INFORMATION:

All proceeds from the 2005 Bond Issue and all interest earned on those bond proceeds and all other related revenues associated with carrying on the construction projects that were the original goals of that bond issue have been completed. The completion of these projects required the spending of \$1,379,600 transferred to the Construction Fund from the General Fund.

Because all the goals of the original issue have been completed, the Construction Fund has been closed. Approximately \$ 139,291 of the \$1,518,891 transferred to the Construction Fund in the fiscal year ending June, 2009, was transferred back to the General Fund.

The closing of the Construction Fund also ends the District's responsibility to continue the monitoring of the Construction Fund for compliance with IRS arbitrage regulations.

The transfer of \$139,291 to the General Fund requires the District to amend the General Fund budget to account for these additional resources and the intended expenditures to be made with those resources.

The proposed budget amendment will reflect the additional money available due to the transfer of \$139,291 and additional budgeted expenditures as follows:
