MEMORANDUM OF UNDERSTANDING (MOU)

Between

Eagle Pass Independent School District

And

Eagle Pass Public Health Coalition

Date: April 1, 2024

1. PURPOSE

This Memorandum of Understanding (MOU) establishes a cooperative relationship between Eagle Pass Independent School District (hereinafter referred to as EPISD) and the Eagle Pass Public Health Coalition (hereinafter referred to as EPPHC) with the aim to enhance public health education, awareness, and services within the school community of Eagle Pass, Texas.

2. SCOPE

Under this MOU, EPISD and EPPHC agree to collaborate on initiatives that may include, but are not limited to, public health awareness campaigns, student and staff health screenings, health education programs, and emergency health response planning and execution within the schools under the jurisdiction of EPISD.

3. RESPONSIBILITIES

EPISD agrees to:

- a. Provide facilities and logistical support for health-related programs and events.
- b. Promote health education among students, staff, and the school community through various channels, including the use of the Remind app, to disseminate information regarding public health initiatives, events, and emergency health notifications in coordination with EPPHC.
- d. Utilize data sets provided by EPPHC to inform and enhance health education programs, policy development, and community outreach efforts.

EPPHC agrees to:

- a. Offer expertise and resources for health education and services, including content that can be disseminated through EPISD's Remind app. This includes providing EPISD with educational materials (such as flyers, infographics, and digital pamphlets) on various health topics, which EPISD will distribute to the school community through the Remind app.
- b. Educate on local and regional health services available to students and families, aimed at

filling gaps in the healthcare continuum, including the creation and provision of materials specifically designed to inform about these services.

c. Make available to EPISD relevant health data sets for the purpose of supporting educational programs, facilitating research, and aiding in the development of health policies and strategies. EPPHC will ensure that all data shared complies with applicable privacy laws and regulations.

4. TERM

This MOU shall be effective as of [Insert Start Date] and shall remain in effect until 12/31/24 unless terminated earlier by mutual written agreement of both parties.

5. AMENDMENT

This MOU may be amended at any time by mutual written consent of both parties.

6. TERMINATION

Either party may terminate this MOU upon 30 days' written notice to the other party.

7. LIMITATION OF LIABILITY

Neither EPISD nor EPPHC shall be liable to each other for any indirect, special, incidental, or consequential damages arising out of this MOU.

8. SIGNATURES

This MOU represents the mutual agreement between EPISD and EPPHC and is executed by the authorized representatives of both parties.


