Supt. O'Neill discussed the resolution asking for a renewed commitment to literacy across our region.

D. Legislative Update

Supt. O'Neill reported that many budget vetoes have been restored and will be voted on tomorrow. He will keep the board updated as things are restored. He also reported that the online sales tax bill has gone through the House and will generate approximately \$90 million next year. The school aide fund is set to receive 75% of it. The curriculum change bill (personal curriculum for students with disabilities) is working its way through the House.

 - 2. Bond Facility Update Due to a scheduling conflict, Asst. Supt. Goss provided an update on the bond funding and participating in the school bond fund lending. There is a meeting scheduled on January 8 with the Dept. of Treasury to discuss details of the loan. Bonds from 1991 will be repaid in May of 2020, a new bond at that time will not increase taxes for the taxpayers. In fact, the rate may be reduced.

Asst. Supt. Goss explained the Facility Assessment study and how to interpret the data. This study guides the way to creating a master plan for building improvements. Asst. Supt. Goss answered questions from the Board.
