A. TPSD Strategic Planning Survey Results

At the noon meeting Dr. Randy McCoy, Mrs. Diana Ezell and Mrs. Kay Bishop presented a summary of the recent Strategic Plan Survey. At the 5:00 p.m. session, Superintendent Randy McCoy summarized the report for the benefit of those not present at the noon meeting.

B. Dropout Prevention Summit Report

At the noon meeting Dr. McCoy reported on the Destination Graduation Adult Summit held on February 28, 2008, in Jackson, Mississippi. Dr. McCoy reported that hundreds of state and local leaders from all sectors — business, faith-based, economic, community, government and education — attended the Summit to focus on the critical issue of reducing our dropout rate by 50% over the next five to seven years.
