We are hopeful that s.a.s.s. which is one of the assessments that we do to measure where we are at and to see if we are at full implementation for tier one. Currently we are hopeful that we will start tier two in the elementary at the beginning of next year. At the Middle School and High School we hope to implement tier two the following year. Nathan Hanson reported that there are two different RtI's. There is an RtI law that has gone into effect December 1st that requires us to follow some very stringent criteria in order to qualify students for learning disabilities. The other side of this is RtI practice which is good instruction.
