5. ACTION ITEMS

A. Bond Refunding Sale, Gary Kawlewski, Director of Finance and Operations Ehlers representatives presented on the bond refunding sale. Received 9 bids today with lower than projected interest rates. \$5.7 million in bonds were sold. Moody's rating was Aa2. Low bid of 2.1033% was made by Fifth Third Securities, Inc. Closing date is set at May 17, 2018. \$257,000 in interest will be saved. 6.8 million dollars has been saved over the time of these bonds.

Sansevere/Brings to award the Sale, Determining the Form and Details, Authorizing the Execution, Delivery and Registration, and Providing for the Payment of General Obligation School Building Refunding Bonds, Series 2018A. Motion carried 7-0.

- B. Bid Awards, John Heltunen, Director of Buildings and Grounds
 - 1. Building Controls Replacement BHS

Received one bid. Could be due to the technology side of project including data servers, etc. Project eliminates the pneumatically actuated components that regulate HVAC equipment at the High School, replacing them with digitally actuated components and wiring. The alternate to complete the replacement of variable speed drives came in over budget and will be rejected.

Brings/Raymond to award the bid to UHL Company at a bid of \$532,575. Motion carried 7-0

2. Outdoor Fields – BCMS

Nine bids were opened on April 19, 2018. Project is to improve the field area between the middle school and the stadium and to create an additional ball field. Fields will be seeded by the same company as at the high school. Fields will be ready for use in the fall of 2019.

Ogden/Lee to award bid to Land Pride Construction at a bid of \$173, 887.35. Motion carried 7-0

C. Capital Facilities and Long-Term Facility Maintenance Budgets 2018-19, John Heltunen, Director of Buildings and Grounds

Budget is created in consultation with building principals and head engineers. Projects include the remodel of the original principal's office into a classroom at DES, movement of the MESI playground, security fob system upgrades, annual health and safety projects, the first phase of the rigging project of the BHS PAC, abatement projects at HES, DES and BCMS and continuation of classroom updates at PES.

Discussion: consideration of funding that is being talked about at the state level for safety and security – no determinations made at this time. Motion carried 7-0

 D. 10-Year LTFM Plan, John Heltunen, Director of Buildings and Grounds and Gary Kawlewski, Director of Finance and Operations
 This is the third year of the 10-year plan. Budget expenditures include Health and Safety and Deferred Maintenance costs.

E. 2017-18 Budget Adjustments, Gary Kawlewski, Director of Finance and Operations

This is the final budget adjustment for the 2017-18 budget. Fund balance is projected to be at 12.16% for unassigned/unrestricted. Food Service fund will have a positive fund balance. Community Ed Fund includes the closing of the Little KidKare Program and a deficit fund balance. Building Construction Fund is ahead of schedule for payouts of the various bond projects. Debt Service fund includes the bond refunding that was approved earlier in this meeting.
