We are pleased to submit this proposal for your consideration:

Bid: Chain Link Fence Commercial/Industrial Grade

D&C Fence Co. will furnish and install 165'LF of 6' tall 9-gauge 1.2oz galvanized coating chain link fencing topped with 3 strands of 12.5ga class III barb wire; using (3) 3" SCH40 terminal posts, (5) 1-5/8" SCH40 braces with truss rods, 2-1/2" SCH40 line posts, 1-5/8" SCH40 top rail, and 7-gauge bottom wire and vertical barb arms. Footings will be 12"x42" on all terminal posts and all line post set on 10' centers in 12"x36" concrete footings. D&C will build and install (1) 4LF personnel gate, 6' tall; using (2) 4" SCH40 gate posts in 12"x42" concrete footings, 2" SCH40 pipe frame, bulldog hinges, and a fulcrum latch. D&C will furnish and install 170' of 3 strands of 4-point 12ga barbed wire with class III galvanizing to an existing 6' chain-link fence, using 2 3/8" vertical barb arms.

D&C will furnish and install 100' LF of 8' Industrial grade chain link fencing; using (3) – 4" SCH 40 terminal posts, 2-3/8" SCH 40 line posts, 1 5/8" SCH 40 top rail, and 9 gauge chain link fabric with 1.2oz galvanized coating. All terminal posts and gate posts will be set in 12"x42" concrete footings. All line posts will be set on 10' centers in 12"x36"concrete footings.

D&C will furnish and install (1) TyMetal Structural aluminum Cantilever gate for a 33LF opening, 8' high; using (5) 4" SCH40 gate posts with header welded to gate posts, double truss-track rollers, bottom guide rollers.

D&C will install (1) 220-volt Liftmaster chain driven gate operator w/ battery backup using (1) operator stand, (1) tech pole, (1) photo eyes to help prevent accidental entrapment, obstruction sensing edge. D&C will test all limits and safeties to ensure proper gate operation.

D&C will run 362' of electrical and conduit to provided power to gate operator location. D&C will make all connections.

Bid: Chain Link Fence Commercial/Industrial Grade

D&C Fence Company will tear out and haul off 250'LF of 8' tall chain-link fencing. D&C will furnish and install 250 'LF of 8'+1' tall 9-gauge 1.2oz galvanized coating chain link fencing topped with 3 strands of 12.5ga class III barb wire; using (6) 4" SCH40 terminal posts, (6) 1-5/8" SCH40 braces with truss rods, 2-1/2" SCH40 line posts, 1-5/8" SCH40 top rail, and 7-gauge bottom wire and, 45-degree barb arms. Footings will be 12"x42" on all terminal posts and all line post set on 10' centers in 12"x36" concrete footings.

D&C Fence Co. will rework an existing 30' V-track gate using the existing 2" SCH40 pipe frame new 4" heavy duty ball bearing V-track rollers, 1" heavy duty V-track on 1/4"x6" galvanized plate, and 6" upper guide rollers. Gate will be topped with (3) strands of new barb wire.

D&C will install (1) Liftmaster chain driven gate operator w/ battery backup using (1) operator stand, (1) tech pole, (1) photo eyes to help prevent accidental entrapment, obstruction sensing edge. D&C will test all limits and safeties to ensure proper gate operation.

D&C will use the existing electrical to make the connections to the operator.

D&C will install (2) sets of Triangle Bollard system using (3) 4" SCH 40 posts spaced 3' apart, set in 36" concrete footings with a 2" SCH40 pipe welded between and painted safety yellow.

In case payment is not made as specified in (Terms) D&C Fence Co., Inc. reserves the right to repossess all materials used on this job without recourse. Buyer agrees to a charge of 1 1/2 per month or 18% annual percentage rate on past due balance and to pay a reasonable fee if it becomes necessary to refer this contract to an attorney for collection.

Unless otherwise specified customer is responsible for clearing all bushes, trees, and debris from the fence line in order to remove and install the fence.*



- Communications pathway for fiber optic cabling to new tech pole and gate opener with communications box
- New tech pole

Alternate Proposal

- Additional communications pathway (1 ½" conduit) from new communications box to new tech pole. From the new tech pole trench to existing gate opener.
- New tech pole
- ★ Existing gate opener
