All members voted in favor of the motion. The motion carried.

IV. Approval to Order Special Tax Ratification Election

The motion was made by Mr. Sult and seconded by Mrs. Evans to Order a Special Tax Ratification Election to be held on November 3, 2015 pursuant to Texas Tax Code §26.08 and 26.05 to ratify the tax rate set for the 2015-2016 school year.

All members voted in favor of the motion. The motion carried.

V. Approval of Final Budget Amendments for 2014-2015

The motion was made by Mrs. Evans and seconded by Mrs. Vanden Berge that the Board approve the Final Budget Amendments for 2014-2015 in the General Operating Fund and Debt Services Fund as presented. A copy of these amendments is attached hereto and shall become an official part of these minutes.
