**Board Goals for 2023-2028**

☐ **Goal 1\*:** The percent of 3rd grade students that score meets grade level or above on STAAR Reading will increase from 49% to 60% by June 2024, 65% for 2024-2025, 70% for 2025-2026, 75% for 2026-2027, 80% for 2027-2028. **(HB3 Required Goal)**

☐ **Goal 2\*:** Increased overall student performance in mathematics to 85% Meets Standard by 2028. The percent of 3rd grade students that score meets grade level or above on STAAR Math will increase from 53% to 65% by June 2024, 70% for 2024-2025, 75% for 2025-2026, 80% for 2026-2027, 85% for 2027-2028. **(HB3 Required Goal)**

☐ **Goal 3\*:** The percentage of graduates that meet the criteria for CCMR will increase from 72% to 88% by August 2024 and increase to 95% by 2028. **(HB3 Required Goal)**

**Background Information:** **The five year agreement with Deep East Texas Self Insurance Fund,**

through local agent Barnard Donegan ended last year. They are only offering one year agreements going forward at this time. The new estimated fee provided for the 2025-26 school year was \$70,327.00.

The district also requested a quote from the TASB Risk Management Fund. Their quoted price was \$73,188.00.

Deep East Texas Self Insurance Fund has supplied the district with excellent customer service with all workers comp claims. Human Resources is extremely pleased with their response to the district's needs. If for some reason NISD is not satisfied with the performance of Deep East Texas, NISD can discontinue the association with a 180 day written notice.
