The Board of Trustees of the Tupelo Public School District convened in a regular meeting of the Board held in open session at 5:00 p.m. on Tuesday, September 28, 2010, at Church Street Elementary School, 445 Church Street, Tupelo, Mississippi.

A. Proposed Tupelo High School Canopy Addition Project

At the noon briefing session Executive Director of Operations Julie Hinds presented for consideration for approval three options for a proposed Tupelo High School Canopy Addition Project with JBHM Architects. Mrs. Hinds reported that, if possible, Qualified School Construction Bond (QSCB) funds will be used to finance the proposed project.

At the 5:00 p.m. meeting of the Board, on a motion by Mr. Prather, seconded by Mr. Nail, the Board voted unanimously to table approval of the THS Canopy Addition, and requested that this project be included in the listing of total projects to be funded by the Qualified School Construction Bond.

Upon motion duly made, seconded, and carried, the President of the Board declared the motion passed. A copy of the proposed THS Canopy Addition Project is marked EXHIBIT 9 and held in the Exhibit Book of this meeting date and incorporated herein.

B. Tupelo Public School District Marketing and Communication Plan 2010-2013

G. Shortfall Note Sale Resolution

Finance Director Linda Pannell presented for consideration for adoption a Resolution authorizing and directing the issuance of two hundred fifty-eight thousand, five hundred sixty-eight and no/100 dollars (\$258,568.00) principal amount shortfall note of the Tupelo Public School District.

Mr. Prather moved to adopt the Resolution as presented. The motion was seconded by Mr. Nail and was approved unanimously. The President of the Board declared the motion passed.
