## Correspondence

- We received notification from the State Department of Education that "Minidoka School District Literacy Intervention Plan for 2017-18 has been accepted by the Office of the State Board of Education and the versions submitted on December 18, 2017 (plan narrative) and September 28, 2017 (budget) are in alignment with Idaho law." They also asked, because of the quality and clarity of our plan, for permission to share our plan with other Districts, which we of course granted. - Building Instructional Sweeps We started our Instructional Sweeps at Acequia Elementary on January 10. The Administration Team developed a document (attached) that is used when observing classrooms focusing on our Priority focus. The data collected is used to provide feedback to the building principal and staff on how effectively they are working towards the District Priority Focus.

We will be working with the ARTEC Board on an additional contract for fiscal services for this new school.
