In addition to our own warehouse facilities (10,000 square feet), Intech Southwest also has an agreement with CEVA Logistics for additional warehousing space (20,000 square feet) in the event of very large staging requirements prior to deployment.

Asset Tagging

Intech Southwest has asset tagging equipment on hand that we use to create asset tags for our customers if needed or not provided by the customer. Intech Southwest will un-box all of the selected product, asset tag the product and then scan the information into either a database or spreadsheet (customer choice) matching it up with purchase order or pre-designated asset information. Custom Asset Tag creation is an option for our customers and we maintain software for tag creation to customer specification.

Network deployment

Intech Southwest will stage all networking equipment and configure according to customer requirements.

Integration

Intech Southwest has a fully trained technical staff with HP and Dell certifications. We are capable to custom integration for upgrade components such as video cards, memory and hard drives during the staging process.

Repair

Intech Southwest is a fully authorized HP and Dell Authorized Repair Center. Any DOA product can be repaired before it reaches the School District facilities.

♦ Transport

Intech Southwest maintains a local fleet of vehicles capable of palletized transport of hundreds of desktop and laptop CPUS at a time within the San Antonio area.

Installation

Intech Southwest has an experienced technical and installation crew with a background of working in the public sector. Installation begins with unloading and localized staging within the selected area. Deployments are done one group at a time and involve setting up the computer, monitor and/or laptop with docking station components. Keyboards, mice, printers, scanners and other accessories are included within this process. Wire management and consolidation is utilized to provide end user satisfaction. Connectivity of the client to the server is performed as a last step of installation and includes running scripts or downloading necessary software to the CPU.

◆ Data Transfer

Existing Data that needs to be migrated can be migrated to an internal storage location (such as a Storage Area Network or Network Attached Storage) prior to installation of the new PC. Software that requires re-installation is requested to be present as an executable file or ISO image via an accessible server as well. After data is uploaded to the storage location and software programs are verified the old system is taken offline and the new system is installed. Software programs are loaded first and then data is brought back down into folders on the new system. The object and goal of data transfer is to make the new desktop environment resemble the old one as closely as possible to maintain customer satisfaction.

Missing software installation keys for individual programs may result in an additional charge per installation if Intech is responsible for contacting software companies for new install procedures.

♦ Trash Removal

Intech Southwest removes all trash from the customer site including unwanted documentation, Styrofoam, cardboard and plastic wrapping material. This material is recycled when possible. It is the experience of Intech Southwest that using customer dumpsters presents problems so we maintain the burden of trash removal.

Inventory

Intech Southwest scans all installed systems and matches the room numbers with Asset Tags/Serial numbers in a pre-described method agreed upon by the customer. An Excel or database format is presented to the customer for asset tracking purposes. Intech Southwest provides this data to the customer and retains a copy within our records as well.

Custom Installation

Intech Southwest has experience with customer mounting solutions that may be necessary such as locks, science equipment and computer furniture.

■Project Management

Based on our staff resumes and the School District's project needs, we have put together the following proposed project management team.

- Account Executive: Sam Lopez: Responsible for managing all product, services, and sales
 contact between the Intech Southwest development team and the SCHOOL DISTRICT. Sam
 Lopez has been an Account Executive at Intech Southwest for over 6 years.
- Inside Sales Representative: Stephen Delgado: Inside Sales Rep will act as a 2nd point of communication and support to better serve the SCHOOL DISTRICT.
- Logistics manager: Chris Schultz: The logistics manager is responsible for internally managing our operation teams to meet customer schedules and budget constraints.
- **Technical Team Lead: Brady Svadlenak**: The technical team lead is responsible for managing our full-time staff of technicians and all contractors. The technical team lead answers directly to operations manager and project managers.
- System Engineer: Steve Smith: The System Engineer is responsible for coordinating advanced services and solutions with the SCHOOL DISTRICT such as Image Creation, Active Directory and deployment scripts. While these services may not be utilized in every case they are available.
- Warehouse Manager: Roberto Ramirez: The warehouse manager is responsible for asset tagging, order and asset documentation, product staging and transportation arrangements.

The contact person will be your main contact point to the project development team. All decisions must be cleared through the team contact person and project manager. Subordinate team members should not be contacted directly unless cleared by the team contact, project manager and team leader.

The Client Contact and Project Manager will both interact directly with all groups at the School District including the Technology Director, Project Manager and Technical Services Team. Rather than have just a sales contact available to the School District, Intech Southwest believes strongly in working directly with the manager of the project itself so that any issues can be addressed directly and improved upon with maximum efficiency. Intech Southwest believes in consistent communication with our customers to insure there are no surprises or confusion on either end before a project begins.

■Logistics

The logistics required for the successful completion of the project are outlined below. Intech Southwest has experience in the complex business operations required by the project and will ensure an optimized, cost-effective, and competitively advantageous solution.

This is a recommended outline for a maximized deployment with the intent to minimize resources needed from The School District to complete each project. While not all of these services may be utilized according to the needs or wishes of the customer, this will provide an outline for a step by step process of a typical successful deployment.

Logistics Services:

♦ Supply Chain Management

An order is placed by the School District with the selected vendor. If the order is placed with Intech Southwest the order will be tracked and ETA's given within the parameters of the deployment project. Time and date of installation can be confirmed within a few days of the order placement. If orders are placed with other vendors Intech Southwest will rely on information from the School District for delivery dates and times.

♦ Warehouse Logistics

Product slated for deployment arrives at Intech Southwest directly. If product arrives at the School District warehouse Intech Southwest picks up the product and transports it to the Intech Southwest Warehouse. The School District is provided with receipt of transport.

♦ Inventory and Software Management

Product is unpacked and powered on. Product is then imaged with the selected software load

that is designated by the School District. Product is asset tagged, scanned into the Intech Southwest database and then re-packed within the same box it arrived in. Product is palletized for transport referencing the campus that the PO designates.

Shipping and Transportation Logistics

Product is loaded onto an Intech Southwest truck and transported to the campus destination on the day of the deployment activity. Product is unloaded onsite via pallet jacks and taken to the temporary pre-destined staging area. Only the amount of product that will be deployed that day is taken and the remainder will remain at the Intech Warehouse until it is ready to be deployed. This will minimize the security needs at the School District for a secure staging area at every campus until all work is performed. A packing list is generated and provided to the School District for its records of the transport to the campus.

Logistics Optimization

Products is deployed onsite for installation. A typical installation includes the following 11 steps:

- Network switch rack and stack switch, wire and dress existing cabling, and configure
- 2. Access point deployment- mount AP configure to network
- 3. CPU Setup
- 4. Monitor Setup
- 5. Keyboard, Mouse and Monitor Cable hooked up to CPU
- 6. Power Management (Surge Protector or wall plug)
- 7. Cable Management (Loose Cables tied and secured)
- 8. Printer/Scanner installation (when required)
- 9. Power On and Connectivity of the Client to the Server
- 10. Insure Internet connectivity and initiate software download if necessary
- 11. Scan and record asset information and location of asset
- 12. Trash and debris removal from job site
- 13. Quality Control

♦ Project Management

In the event of network issues or logistical issues such as locked doors the appropriate

personnel within the School District will be notified. The typical point of contact for campus at the School District access is usually the custodial staff. Intech Southwest makes it a point to introduce our Team Leader to the custodian at every location before work begins that day. It is preferable that the custodian have a cell phone number that they can be reached at, but if not Intech Southwest will furnish them with a local 2 way radio for communication for the duration of the campus project.

♦ (EDI) Electronic Data Interchange

Asset Information will be provided to the School District in a spreadsheet or database format. Typically Excel is used for this information because it's easy to upload to a database and it's easy to look up information in this format. Intech will email this information to the School District contact and also retain a copy for our own records.

■Quality Control

Intech Southwest has implemented a quality control system to ensure that this project meets or exceeds the specifications.
