**Subject:** Consider Approval of the Guaranteed Maximum Price for the 2023 Bond First-Sale Lewisville High School Scene Shop Addition and Band Lot Renovations Project (AB01)

### Background Information:

- The 2023 Bond First-Sale Lewisville High School Scene Shop Addition and Band Lot Renovations Project has been assigned to Huckabee as the architect at the December 11, 2023, Board Meeting and Reeder Construction as the Construction Manager at Risk firm by the Board of Trustees at the May 13, 2024, Board Meeting.
- The Guaranteed Maximum Price (GMP) process was presented to the Board in a Discussion Item at the February 5, 2024, Board Work Session.
- This project includes a new scene shop, storage, and a new classroom as well as renovations that provide a second classroom and offices for the theatre program.
- The 2023 Bond First-Sale Lewisville High School Scene Shop Addition and Band Lot Renovations Project has been advertised and competitively bid to sub-contractors by Reeder Construction, the Construction Manager at Risk firm. The sub-contractor bids have been evaluated and scoped for this project. Reeder Construction has presented a Guaranteed Maximum Price (GMP) for this project.
- Reeder Construction has presented a total Guaranteed Maximum Price for the 2023 Bond First-Sale Lewisville High School Scene Shop Addition and Band Lot Renovations Project of \$6,158,306.
- The pricing exceeds the overall project budget by approximately \$2.8M.

### Administrative Consideration:

- Funding for this project is provided from the 2023 Bond Funds.
- Land Sale proceeds, Bond project savings, and Bond interest earnings are all available to cover the \$2.8M budget overage.
- The procurement complies with Section 2269 of the Government Code.

### Recommendations:

- That the Guaranteed Maximum Price of \$6,158,306 for the 2023 Bond First-Sale Lewisville High School Scene Shop Addition and Band Lot Renovations Project by Reeder Construction be approved.
- That Land Sale proceeds, Bond project savings, or Bond interest earnings be used to cover the \$2.8M budget overage.

- That the Superintendent, Chief Financial Officer, or Executive Director of Procurement and Contracts be authorized to sign any documents to implement this action.

**Timeline/Report:**

- Upon approval, sub-contracts will be executed, materials will be ordered, and work will begin. It is anticipated that construction will begin the summer of 2025 and will continue into the school year and finish April 2026.
