May 23, 2017

The Collin County Community College District ("Collin College," "Collin," or "District") conducted its regular monthly Board of Trustees meeting on May 23, 2017, in the Board Room, Room 139, Collin Higher Education Center, with Chairman J. Robert Collins presiding. Trustees in attendance were Dr. Collins, Dr. Stacey Donald, Mr. Andy Hardin, Mr. Mac Hendricks, Dr. Raj Menon, Mr. Fred Moses, Mr. Jim Orr, Mr. Adrian Rodriguez, and Ms. Nancy Wurzman. Other attendees included District President Neil Matkin, Collin College administrators, faculty, staff, and community members.

CALL TO ORDER

Chairman Collins called the May 23, 2017, meeting of the Board of Trustees of Collin County Community College District to order at 5:30 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

Notary Public Shirley Harmon administered the oath of office to Fred Moses, Place 1, for a term ending May 2023; Nancy Wurzman, Place 2, for a term ending May 2023; Dr. Stacey Donald, Place 3, for a term ending May 2023; and Dr. Raj Menon, Place 5, for a term ending May 2019. Each Trustee signed the Statement of Elected Officer prior to the swearing in and the Oath of Office documents immediately after.

Dr. Menon seconded and the motion to cease nominations was unanimously approved. A vote on the motion to elect Andy Hardin as Vice Chair of the Board of Trustees of Collin County Community College District was unanimously approved.

Mr. Hardin made a motion to nominate Mr. Jim Orr as Secretary. Mr. Moses seconded the motion. There being no other nominations, Dr. Menon moved that nominations cease. Mr. Rodriguez seconded and the motion to cease nominations was unanimously approved. PUBLIC COMMENT

The following public comment was presented.

Greg Gomel, Community Member: Mr. Gomel said that during his election campaign for trustee, the question came up as to why the SAIL program out of the Courtyard Center was closed to new members. He said he wanted to see what opportunity exists to expand that program and allow it to be spread to the other campuses. Chairman Collins said that the question would be submitted to President Matkin and his staff.

PRESENTATIONS

1. Collin County Dual Credit Program 2015-2017 – Dr. Sherry Schuman, Sr. Vice President of Academic, Workforce, and Enrollment Services presented an update on Collin College's dual credit program with the following information:

- Collin College currently serves 17 independent school districts (ISDs).
- The High School Dual Credit program is under the leadership of Associate Vice President Raul Martinez and is part of the P-12 partnerships.

- The High School Dual Credit Program works with 46 schools including public, private, and home school co-ops.
- Collin College offers 76 different academic and workforce courses.
- High school dual credit enrollment increased over 20% from fall 2015 to fall 2016.
- Headcount when the program started in 1987 was 67; in fall 2014 headcount totaled 3,138, fall of 2015 headcount was 3,766, and fall 2016 totaled 4,557.
- Strategic Priority 2 is to increase and create streamlined pathways from high school to college. By 2020, the target is 6,100 students. Over 70 additional sections will be offered next year.
- Currently, 14 schools allow students to earn 30 hours (or more) of dual credit. Eleven schools allow dual credit of less than 30 hours. Collin will offer 30 credit or more at 59% of ISDs, and 30 credits or more at 69% of high schools.
- Significant opportunity for growth as dual credit offerings become available to high school freshmen and sophomores and when ISDs do not limit to junior and senior years.
- New dual credit courses and programs added or expanded since 2015 include:

- Student Support Services provided to ISDs

- Dual credit offers significant savings for students who earn 30 dual credit hours or more then transfer to the university. An example was given of a university cost of \$30,000 for those same hours that would save a student approximately \$28,000 of that cost by transferring in dual credit.

President Matkin said he would be talking with superintendents regarding dual credit versus advanced placement (AP) credit. Some schools currently offer grade point average (GPA) advantages for AP credit, but not dual credit.

2. Faculty Council Transition and Update – President of Faculty Council/Professor Regina Hughes presented an update on Collin College's Faculty Council.

Faculty Council President Regina Hughes said the faculty organization was founded in 1987 as a Faculty Senate with the first President being Dr. Martha Ellis. It was changed to Faculty Association in 2005. In 2006, the name was changed to Faculty Council and campus represented were elected to two-year terms.

Ms. Hughes said the Faculty Council represents Collin College faculty in college matters and is responsible for the following:

- Supporting the College mission and core values,
- Safeguarding academic freedom and promoting academic excellence in the classroom, the College District, and the community,
- Participating in College District shared governance,
- Promoting effective communication among faculty, between faculty and administration, and between faculty and student services,
- Promoting unity and cohesion among the faculty, and
- Promoting the professional, economic, and social welfare of the faculty.

The 2015-2017 organizational structure of Faculty Council follows: Elected body, 25 campus representatives from full-time faculty, including 12 at the Spring Creek Campus, 7 at Preston Ridge Campus, and 6 from Central Park Campus. They serve two-year staggered terms. The President and Vice President of Faculty Council are elected at-large; the Secretary and Treasurer are elected from within the Council. One associate faculty representative serves on Faculty Council. The Council meets monthly with additional meetings of the standing or ad-hoc committees held as needed. The FC President and officers may meet over the summer. The FC President meet with Executive Vice President Brenda Kihl, serves as a member of the Executive Leadership Team, and the FC President and Vice President are members of the Committee of the Whole.

Ms. Hughes thanked President Matkin for his support, openness, leadership, and generosity of time during her tenure as Faculty Council President. She thanked the 2015-2017 FC officers and leaders, Dr. Kihl and the Executive Leadership Team, and staff who were helpful during her presidency.

Ms. Hughes introduced President-elect of the Faculty Council Dr. Nick Morgan, who will now be serving on the Executive Leadership Team. He commented that both Dr. Matkin and Ms. Hughes had come to their positions at a tough time for Faculty Council and much progress had been made since 2015. Dr. Morgan said he looked forward to the opportunity to continue that progress in the upcoming year.

2017-5-3-2 Approval of Designated Delivery Method for Construction of the Wylie Campus and the Technical Training Center

Discussion: District President Matkin presented discussion on approval of the designated delivery method for the Wylie campus and the Technical Training Center. Inasmuch as Collin College is a public junior college authorized under Chapter 130 of the Texas Education Code, the College is required by Government Code Section 2269.056 to determine, before solicitations for services are issued, which construction delivery method provides the best value for the College.

The Government Code authorizes six (6) construction delivery methods: competitive bidding (combines design, bid and build); competitive sealed proposals; construction manager-agent; construction manager-at-risk (CMAR); design-build; and job order contracting. Of the six authorized methods, staff believes the CMAR method will provide the best value to the College. Under the CMAR methodology, the services of the general contractor are divided into two distinct areas:

(1) Preconstruction - during which the CMAR acts as a consultant to the design team during the design development stage and works closely with the College and its architect to advise on constructability, materials choices and to offer expert cost estimation services to assure that the project stays in budget; and

(2) Construction - where the CMAR provides project administration services and supervises and/or performs the actual construction through subcontractors and/or its own forces while keeping the project costs within the guaranteed maximum amount approved by the Board of Trustees.

Selection of the CMAR to provide the above services is recommended by staff using the two-step process as outlined in Government Code Sec. 2269.253. Using this process Collin College would identify finalists based solely on qualifications then, in step 2, evaluate additional information from those finalists including the CMAR's proposed fee and prices for fulfilling the general conditions. Then, on that basis, the CMAR that provides best value to the College would be recommended to the Board for each project.

Designation of the CMAR delivery method triggers the Request for Qualifications solicitations process for an Architect for each project, which is also a two-step solicitation as required by Government Code Section 2254.004(a) which states "In procuring architectural, engineering, or land surveying services, a governmental entity shall: (1) first select the most highly qualified provider of those services on the basis of demonstrated competence and qualifications; and (2) then attempt to negotiate with that provider a contract at a fair and reasonable price."

Beyond approval of the construction delivery method, the Board will approve selection of the CMARs and architects when the administration brings agenda items for the following:

- (1) Consideration of Approval of Contract Forms (Architect and CMAR July 2015 2017)
- (2) Consideration of Approval of Project Assignments (Negotiate and Execute August 22, 2015 2017)
- (3) Consideration of Acceptance of GMP (Foundation & Site Work TBD April 2018)
- (4) Consideration of Acceptance of GMP (Facility TBD September 2018)

Additionally, Board involvement will occur on a regular basis via detailed monthly reports to the Campus Facilities and Construction Committee, Board information reports to be included in the monthly board agenda, and information available to the Board and public via a web portal.

In answer to Mr. Hardin's question, President Matkin provided the correct the dates in items 1-4 as reflected on the previous page.

After discussion by the board, Mr. Rodriguez made a motion that the Board of Trustees of Collin County Community College District approve the construction manager-at-risk (CMAR) construction delivery method for both the Wylie campus and the Technical Training Center. The motion was seconded by Dr. Menon and received unanimous approval.

2017-5-3-3 Consider Authorizing the Use of the Power of Eminent Domain to Acquire Approximately 9.994 Acres More or Less Out of the G.W. Gunnell Survey, Abstract 351 in Wylie, Collin County, Texas as Described in that Certain Deed Dated August 27, 1993 and Recorded at 93-0073282 of the Land Records of Collin County, Texas, and Owned by Deborah Mulcahy, for the Public Use of Constructing and Operating Facilities for Higher Education by Collin County Community College District

Discussion: Pursuant to the Board's prior action on June 28, 2016, the District began the process of acquiring additional property needed for the future construction of District instructional and support facilities in Wylie, Texas. The District has been unable to acquire the Property owned by Deborah Mulcahy, which is essential and necessary to construct these facilities. The Property has been appraised at \$1,340,000.00 and funds currently exist to fund the purchase in this amount along with the costs and expenses of the eminent domain proceeding.

President Matkin said that if approved by the board, it is estimated that the initial offer would be mailed on May 24, a final offer mailed on June 27, and the condemnation petition filed on July 14. It is estimated that the Court would appoint Commissioners between July 14-August 4 and a special commissioners hearing would be held August 28-September 8 to determine the amount owed for the property.

On motion of Mr. Hardin, second of Mr. Orr, the Board of Trustees of Collin County Community College District unanimously authorized the use of the power of eminent domain to acquire approximately 9.994 acres, more or less, out of the G.W. Gunnell Survey, Abstract No. 351 as described in that certain Deed dated August 27, 1993, recorded at 9370073282 of the Land Records of Collin County, Texas and owned by Deborah Mulcahy for the public purpose of constructing and operating Instruction and Support Facilities to provide academic and other educational programs to the public.

Mr. Hendricks said that, to his knowledge, the college had never used the right of eminent domain, and it is not something the board takes lightly. It is being used only after exhausting all other avenues. The property is located in the middle of the proposed campus and there is no choice, but the Board of Trustees does not make a habit of this. In this case, it is a true need not a luxury.

2017-5-3-4 Approval of an Amendment to the FY17 Budget for Changes in Budgeted Restricted Revenue and Expenses for Grants for the Period beginning May 2017

Discussion: Federal, state, and local/private grant activity is dynamic as amendments to currently active grants are processed and new grants are awarded. In order to fund the objectives of the grants, grant-operating budgets must be established in a timely manner. This request for a budget amendment reflects the additions to restricted revenues and expenses as a result of amendments, new awards, and the carryover of prior year's unspent grant budgets that may be utilized in the current year budget for the period beginning May 2017.
