I recommend the transfer of remaining funds to Education Fund 10 and subsequent closing of the following Funds: Operation and Maintenance Fund 20 (-\$1,786,089.56) Transportation Fund 40 (\$11,839.94), and Life Safety Fund 90 (\$263.59).

On July 21, 2016, the Governing Board approved the Education Fund 10 and Operations and Maintenance Fund 20 be combined, which follows best accounting practices for Illinois Special Education Joint Agreement Cooperatives.

Please note that by transferring any reamining funds to Education Fund 10 and closing the aforementioned Funds, there is no change to the Fund Balance.
