A Board Workshop/Special Session of the Board of Trustees of Graham ISD was held Wednesday, April 22, 2026 in the Graham Learning Center, 701 Tennessee St, Graham, TX 76450. STUDENT SERVICES

Steered Straight Program Overview

Chief Student Services Officer, Joe Gordy shared Steered Straight information with the Board of Trustees. Steered Straight programming was recommended by Graham Police Department and funded through a grant by the City of Graham. Steered Straight programming was reviewed and approved by the Graham ISD School Health Advisory Committee (SHAC) on October 16, 2025. Graham ISD will provide all families with an avenue to consent for participation (We will determine if we opt in or opt out). Assemblies will be hosted at each campus the week of May 18-21. A parent presentation and staff training will also be included.

- A. Real Property
To deliberate the purchase, exchange, lease, of real property if deliberation in an open meeting would have a detrimental effect on the Board's position in negotiations with a third person (Texas Government Code 551.072)
- B. Personnel
To deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee, including Board members, or to hear a complaint or charge against an officer or employee (Texas Government Code 551.074)
- C. Consultation with Attorney
To deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee, including Board Members, or to hear a complaint or charge against an officer or employee, including mid-contract termination of probationary contract employee. (Texas Government Code 551.074)
- D. Security Devices or Security Audits
To deliberate the development, or specific occasions for implementation of security personnel devices or a security audit (Texas Government Code 551.076)
