III. Re: District's Plan Affecting Instruction, Operations, Students and Staff due to Coronavirus Pandemic and Matters Related Thereto

Administration addresses the UISD board to update them on local and state governance regarding the Covid-19 pandemic crisis.

Administration brings up concerns about the well being of faculty, staff and students and brainstorm as to what steps or procedures to implement in order to continue to provide the top level of instruction to all students.

The curriculum and instruction department must check out laptops. Will we prioritize? what levels to start with? Graduating students and students at risk or in programs like Odyssey should take priority. Seniors for example need to meet their credits for graduation.

The technology department will need to provide access to students in order for them to access class work. Student needs, credentials, logins and passwords. What about the individuals who do not have internet?

UISD is requiring that all personal wear the appropriate protective gear. Masks and gloves are being provided by the district and 6 ft. distancing is being implemented. Campuses and department buildings are being sanitized.

Just as important, administration takes a fast action to provide warm meals to all students ages 18 and under. Selected campuses were designated for curb side pick ups that include both breakfast and lunch per student. Send the information on the school sites to social media. March 23, through April 3, 2020. Will we request I.D.'s for students?

Should parents not be allowed to get off their vehicles?

A Call Center has been set in place since day one, to address and listen to parent concerns Mon – Fri, 8 AM to 5 PM 473-8000.

Administration put together a questionnaire and is currently collecting information from faculty and staff for any employee possibly traveling in/out of the city, most especially to and from hot spots where the current pandemic is most prominent. What procedure should be set in place for anyone who has been at risk of contact?

All school-sponsored travel has been cancelled to ensure the safety and well-being of both students and staff. Also all activities, including practices are suspended through May 4, 2020. Legal counsel will prepare/review a resolution to propose such cancellations.

Letter through the human resources department, addressing all full-time employees to ensure them they will continue to get paid, despite the district closure. Substitutes are not full-time employees.

Is the district extending the closure? Will graduation be cancelled?

The district is considering cancel all employee evaluations.

The state announces the cancellation of STAAR/EOC/STAAR Alt for the 2019-2020 school year.

The UISD Administration will work with board members and legal counsel to address the health and safety concerns of all students, faculty and staff of UISD at the next board meeting.
