- Chemical or biological contaminants of the air flowing inside a building.



#### **Action Steps Resulting from TfS Classroom Inspections**



- Immediate written follow up with each staff member confirming findings, and listing applicable follow up items --- (Commended by the State Department of Health for precedent setting best practice).
- Implemented inventory of classroom area rugs to allow for systematic replacement – Phase 1: A-Wing classrooms.
- Continued dialogues increasing understanding of custodial maintenance vs. classroom staff responsibilities.
