PEDICULOSIS (HEAD LICE)

Whenever a student is found to be infested with head lice, **[OPTION #1]** s/he is to be sent home for treatment. If parents cannot be contacted and not readmitted until the parent completes Form 8450A F3 [] and it is confirmed that the child is free of any nits. **[OPTION #2]** s/he may remain in school until the end of the school day but shall be restricted from activities involving close head-to-head contact or sharing personal items with other children.
