The Phase II project this summer at Stevenson High School includes asbestos abatement. We discussed the need to do remedial work for asbestos abatement with the initial discussion of the budget and detail for the total Phase I and Phase II project in October 2011, and continued this discussion at the April 22, 2013 Building and Site sub-committee meeting.

We received bids for the Phase II asbestos abatement work on April 16, 2013. We are recommending the low bidder Qualified Abatement for a total cost of \$63,600. Qualified Abatement was the low bidder for the Phase I asbestos abatement and the budget for the Phase II work was \$87,000. This project will be paid for from sinking funds.
