 - Josh Aurand presented a sales tax referendum presentation. This would act as a show of support for RPS 205 in the adoption of their resolution. This sales tax referendum would not apply to cars, trucks, boats, RV, mobile homes, unprepared foods and pharmacy drugs. This facility sales tax offers the district the opportunity to keep over 1 million square feet of buildings running safe and comfortably and many other outdoor areas in good condition, like chillers and boilers. If RPS 205 approves this resolution at their board meeting, the question goes to the taxpayers and if approved, the District would begin to receive those dollars roughly next October. There were mixed opinions on whether to adopt the resolution to move it forward. In the end, this is a tax payers decision to accept this referendum if or when it is put on the March Referendum.

He discussed the importance of maintaining a balanced budget and the challenges posed by inflation and healthcare costs. Detailing the breakdown o the budget, Josh included projections for various funds and how this will impact on the overall budget.
