Athletics Department Update

Ms. Nikki Nelson presented an update on the Athletics Department for the 2023-2024 school year.

Mr. Hunt asked what the outcome would be if the District continued to use Traylor Stadium. Ms. Nelson said that due to the number of football games scheduled within certain weeks, alternative accommodations are necessary.

Mr. Welch asked if the football games could be live-streamed. Ms. Nelson said that the height of the press boxes at the campus stadiums and issues with internet connectivity present challenges to streaming the games live.

Mr. Hunt asked if a grass football field is more expensive than a turf field. Ms. Nelson said that grass would be more expensive at this point because the irrigation system would have to be reinstalled.

Mr. Welch asked what the funds in bond Proposition D would have been used for if the proposition had passed. Mr. Buchanan said Proposition D included turf replacement, drainage repair, electrical and lighting repair and bleacher repair.

Mrs. Williams asked if security measures would be considered for the varsity football games played at the campus stadiums. Ms. Nelson said she will work with the Lamar CISD Police Department and Security Department to discuss the safety and security logistics for each game.
