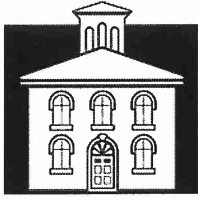

This response is provided in accordance with the Illinois Freedom of Information Act, 5 ILCS 140/1, *et seq.* ("FOIA"). Please see the enclosed records.

Excellence in Education: A Continuing Tradition

As is more fully explained below, certain information has not been produced pursuant to the following FOIA exemptions:

- Pursuant to FOIA Section 7(1)(b), the following information is exempt from inspection and copying: “Private information,” defined in FOIA Section 2(c-5) to mean “unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses” and including “home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person.”
- Pursuant to FOIA Section 7(1)(c), the following information is exempt from inspection and copying: “Personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information.”

The following information has been excluded from the records in accordance with FOIA Section 7(1)(b): personal telephone numbers, personal email addresses, and home addresses. Such information is “private information” within the meaning of FOIA Section 2, and is exempt from inspection and copying pursuant to FOIA Section 7(1)(b).

The following information has been excluded from the records in accordance with FOIA Section 7(1)(c), because disclosure of the information would constitute a clearly unwarranted invasion of personal privacy: middle name and race/ethnicity.

The person responsible for the decision to partially deny the request is Dr. Edward J. Condon, Superintendent of Schools and Freedom of Information Act Officer.

You are hereby notified that you have the right to request a review of this decision by the Office of the Attorney General’s Public Access Counselor, who can be contacted as follows:
