WISEdata Attendance Snapshot: *October 31*

On Tuesday, October 31, 2017, attendance and discipline data from the 2016-17 school year, reported by your local Student Information System (SIS) to WISEdata, will be locked down in the WISEdata Attendance and Discipline Snapshot. After October 31, 2017, these locked data will be used for federal and state reporting, including Accountability Report Cards, and in the WISEdash Public Portal (certified view).

Last year's attendance data plays an important role in future accountability reporting. As a lagging indicator, the 2016-17 data in next week's Attendance Snapshot will be used in the 2017-18 Accountability Report Cards, which are released each fall. These data will also be used in the new federal (ESSA) accountability system, for which we begin reporting next year. As such, districts are encouraged to **verify attendance and absenteeism data by subgroup at both school and district levels.**

- In the federal accountability system, chronic absenteeism is defined as a student missing more than 10% of possible days, and the goal is that no more than 10% of a school's student population is deemed chronically absent.
- In the state accountability system, absenteeism is defined as a student missing more than 16% of possible days, and the goal is that no more than 13% of a student population as chronically absent. It is one of two possible deductions in the Accountability Report Cards. Additionally, school attendance data is used in the On-Track priority area.
- Multiple years of attendance data are used throughout the federal ESSA and state accountability systems.

Given the long-term impact on accountability scores, we recommend districts review their attendance data in WISEdata prior to Monday. Please include principals in this work in order to build understanding of the importance and use of accurate attendance data (i.e. state and federal accountability calculations) at the school level.
