 Information is using 2019 data. Compliance testing must be met in four areas – Completeness and Accuracy Test – form is submitted accurately and on time; Statistical Analysis – our underpayment ratio is higher than 80% as required; Salary

Range Test – District range is 85% (within the 80% or more requirement);

Exceptional Service Pay Test – District range is 119.30%
