Craig's work is rooted in empathy and environmental stewardship, and his designs have helped communities around the world reclaim space with dignity and purpose. His involvement in this project is not only a gift to Uvalde, but a signal to the world that our story matters.

This will not be a conventional building with square walls and divided rooms. The design will be unlike anything in this part of the country, organic, intentional, and deeply symbolic. It will invite movement, reflection, and connection. It will be a monument to resilience and a living space for generations to come. We are building not just for today's needs, but for tomorrow's healing.

We want to be clear: this request is not about exclusivity. If other foundations or community groups bring forward similar proposals rooted in service and belonging, we trust and expect that you will extend your support to them as well. Our hope is simply that, should we be honored with the opportunity to lead this effort, UCISD will be included in our acknowledgments and ongoing collaboration. The district's voice and presence are vital to the integrity and impact of this project.
