Civil Engineering Services for preparation of Construction Documents will be part of the base compensation. Reimbursable Services will include Civil Engineering Non-Design Service, Construction Administration and Attendance at Meetings as noted in the Civil Engineering Proposal, dated, August 1, 2025, attached as Exhibit B. Exhibit B is incorporated hereinto this Amendment.
