## **BACKGROUND/CONSIDERATIONS:**

The administration desires to update the 2025-2026 Fort Smith Public School Student Handbook to reflect and operationalize the recent Board Policy changes on the student level.

On July 10, 2025 the <u>Student Handbook Review Committee</u> met to review the following changes. Members of this review committee voted to bring these proposed changes as written to the Fort Smith School Board. Mr. Marshall Ney has subsequently reviewed and approved these changes to the 2025-2026 Fort Smith Public Schools Student Handbook.

These sections for changes are submitted in both redline and clean copy for Board review. The handbook in its entirety following the individual sectional review.

**Introduction**- Changes made were to align with the update to the Fort Smith Public Schools logo and new district leadership. Changes were made in the Civil Rights Compliance letter to accommodate change in terminology. Revisions were made in the Sexual Harassment of Students or Staff members letter in accordance to changes in Policy - 3.26 Licensed Professional Sexual Harassment and policy 4.27 - Student Sexual Harassment.

Eligibility for Enrollment – This section was updated to coordinate with changes to policy 4.5 - School Choice. Highlights include extending the School Choice deadline from May 1 to June 1, extending support of the enrollment of military-dependent students, and to amend the enrollment of International Exchange students to permit the transfer from the attendance zone of the host family to the school of choice.

**Virtual School Attendance Accounting –** The portion of the Attendance policy pertaining to FSPS Virtual School was eliminated from the handbook.

**Absences** – This section was updated to coordinate with changes to policy 4.7 - Absences. Highlights include absences pertaining to; students who are children of fallen service members of first responders, and absences with parent consent for social or public policy advocacy.

**Legal Notification** – This section was updated to actions that are to be taken by the Arkansas Department of Finance if they are notified a student over the age of 14 is no longer attending school.

**Epinephrine and Emergency Administration of Epinephrine** - This section was updated to coordinate with changes to policy 4.35 - Student Medications. Highlighted is the addition of using nasal spray as an alternative delivery method for emergency dosage of epinephrine.

Graduation Requirements for the Class of 2026 and Graduation Requirements for the Class of 2027 and Thereafter – This section was updated to correspond to changes made in statewide graduation requirements. Highlights include the elimination of the Core Curriculum graduation path, a link to the Fort Smith Public School Course Catalog and the Smart Core graduation requirements provided by the Arkansas Department of Elementary and Secondary Education (DESE); and changing terminology.

Eligibility for Athletic Competition – This section was updated to coordinate with changes 4.56 – Extracurricular Activities – Secondary Schools. Highlights include a delineation regarding eligibility requirements pertaining to transfer status and grade level.

**Student Use of Artificial Intelligence (AI)** – This section was added to the handbook in 2025-2026 to include the adoption of policy 4.64 – Student Use of Artificial Intelligence.
