**Proposed Title IX Regulations; Make Your Voices Heard in DC!**

As the country celebrates the 50th anniversary of Title IX, a new wave of proposed regulations for the statute is being ushered in by the Biden administration. While many of the changes in the proposed regulations are welcome, our national affiliate - AASA - has identified some potential implementation challenges for school districts across the country should these regulations become codified.

Anytime new regulations are proposed, there is a 60 day window for impacted parties to submit public comments to be considered before any regulations become permanent. We are currently in that window, and it will be open until September 12, 2022. As a result of the potential implementation challenges identified by AASA, the organization is urging superintendents to make their voices heard and submit comments to articulate their concerns.

In order to help facilitate that process, AASA has developed a number of resources that can assist in making it easy for you to submit your comments for review.

AASA has published a step-by-step process to follow to submit a comment, as well as created a template letter that you can personalize and attach to your public comment submission. The process, template letter, and link to submit your public comment can be found [here](#).
