Subject: Consider Approval of the Fiscal Year 2025-26 Budget Calendar per CE (LOCAL)

Background Information:

- Board Policy CE (LOCAL) Annual Operating Budget was revised in August of 2023 to codify parameters around the general operating and debt service fund balances.
- Changes to CE (LOCAL) represent added components of annual budget planning.
- For budget monitoring and reporting purposes, the revised CE (LOCAL) includes a
 "Schedules" section that states, "The Superintendent or designee shall supervise the
 development of a budget calendar and a specific plan for budget preparation. The budget
 calendar shall be presented to the Board for consideration in August and adopted no later
 than November."
- The Fiscal Year 2025-26 Budget Calendar was discussed at the August 12, 2024, Regular Board Meeting and the November 4, 2024, Work Session.
