The Issue:

Bid results for 2025 Site Improvements at Gonzales Child Center, Johnson Elementary and Rollins Elementary.

Justification:

In order to continue to make improvements throughout the district in accordance with our 5-year capital improvement plan, we have collected bids for site improvements at GCC, Johnson and Rollins. The work includes seal coating and striping at all three buildings.

A public bid opening was held on March 11, 2025. One bid was received.

Board Policy and Past Practices:

Pursuant to Board Policy 4:60, Supplies, materials, or work involving an expenditure in excess of \$25,000 must comply with the State law bidding procedure, 105 ILCS 5/10-20.21, unless specifically exempted.

Strategic Plan:

This recommendation supports Strategic Goal #2, Operational Excellence that states the following: *East Aurora School District 131 will align and utilize systems and resources that promote operational excellence, efficiency, and fiscal accountability.*
